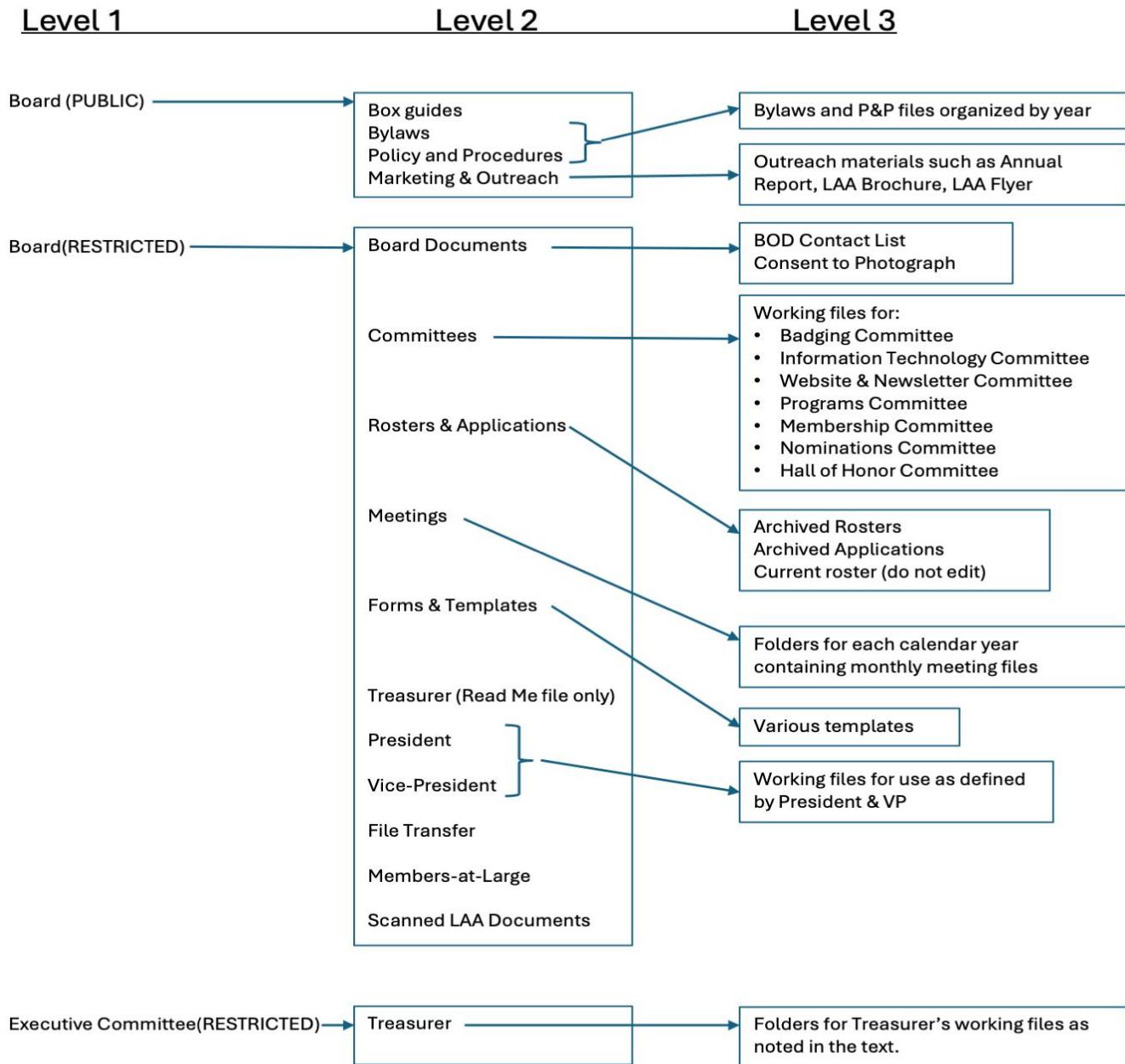
- a) Updated roster format per audit feedback and new terminology in the Policies and Procedures documents

- **Suggest changing committee name to “Website and Publications”**
- **More inclusive; would cover other publications such as:**
 - a) Brochures
 - b) Event posters
 - c) Annual reports
 - d) Other publications as needed
- **Requires a change to Policies & Procedures document**

IT Committee Report – Roman Paryz

- **Several options were discussed to alleviate Vimeo upload limits (25)**
 - Upgrading Vimeo 60 videos max for \$144/year or 120 videos is \$240 / year
 - Box is not a viable option due to upload file size limitations
 - Using YouTube
- **As a potential solution, a YouTube site was created to store the LAA videos**
 - Rich Antcliff created the YouTube site and uploaded several videos for perusal
 - <https://www.youtube.com/@LangleyAlumniAssociation>
 - The site is a "brand" site which means the owners can be changed at any time
 - Four current “owners” are Rich Antcliff, Kathy Ferrare, Rick Ross, & Roman Paryz
 - Maximum storage is 256GB which is considerably more than the Vimeo 5GB limit
 - For a typical 500 MB meeting upload, there is capacity for approximately 500 videos
 - Some video description edits and cover photos may be required
- **Recommend using YouTube exclusively for videos of monthly meetings, linked through the LAA website ~~ Thank you Rich Antcliff!**
- **Follow-On Action:** Links in other LAA sites / documents / newsletters will have to be updated as needed

IT Committee Report – Roman Paryz

- **Rick Ross created @larcalumni.org email addresses for new board members**

- **Langley Exchange (LEA) web page for LAA**
 - Page currently just links to our LAA website
 - Maintained by NASA; we can submit monthly updates
 - Fixed size; limited amount of information
 - **Looking for volunteers to work on content**

Old Business – Outstanding Actions

- **Bring to the Board a proposal for the budget**, as discussed at the January 2024 Board meeting (Ray Rhew – March 2024 action)
 - Status: Ray provided overviews of the last 3 years and a notional proposed budget (see Treasurer's Report); Had Budget Development Process meeting with volunteers on April 17th.
 - May: Ray to bring an update in August.
 - August Update: Per Ray, in good shape to make some decisions on the discretionary Budget. Next step is to develop the plan to execute.
 - Oct/Nov Update: Per Ray, overall budget is good; want to refine discretionary budget. Keep action. Will discuss with Lil Richwine.
 - Jan Update: Ray provided budget overviews; Ray will provide update on outreach discretionary budget at April Board meeting.
- **Retirement Protocol Question (Rich Antcliff)** – What is the protocol policy that NASA follows for retirements (album, certificates, party)? Should the LAA have one?
 - Nov Update: Contacted NASA Langley for information
 - Jan Update: Rick Antcliff to reach out to Langley Human Capital

Old Business – Outstanding Action

- **Pizza Talk Invite/Pizza at Board Meetings Question (Wes Goodman)** – "Pizza Talks" held weekly on Center with respect to LAA badges. He got verification from the Board that our LAA badge is good for us to attend the talks. Rick Ross said that he would pass on the weekly announcements of the topic to be presented that Thursday.
 - September Update / Additional Info:
 - LAA reached out to NASA Langley.
 - The Thursday speakers are organized by NASA Langley.
 - The AIAA organizes speakers about every other month to help Langley.
 - Oct Update: Pizza Talk on Oct 10th was to discuss how it is organized. Wes might attend.
 - CLOSED: Jan Update: Provided information on pizza talk process. Will load information on Box.
- Clarification – Rick Ross receives meeting information when the AIAA sponsors the Pizza Talk. This occurs several times a year.
- Will work on a process for quickly getting the word out about Langley meetings. No LAA one-day badges will be processed; for Non-AIAA lectures no ability for pizza sign-up because requires access through Langley firewall.¹³

Old Business – Outstanding Action

- **Approaching Vimeo upload limits of our presentations**
 - 2 uploads/month, 25 total lifetime video uploads
 - Currently at 84% (21 of 25 videos)
- *Options (need to make a decision NOW!):*
 - Delete older videos to stay below the 25-video limit
 - Upgrade to a paid plan: \$12/month for 60 videos
 - Keep older videos on YouTube, newer ones on Vimeo
- *IT Recommendation: Use YouTube to store videos*
