- **May 2025 Board Meeting Minutes were approved and posted to Box**

- **Significant Motions & Actions:**
 - Discussion of supporting LaRC employees through the current interesting environment
 - Discussion of informing LAA members on useful topics/resources at meetings and on website, possibly providing a template for the presentation

Membership Badging Item

- NASA LaRC has a new option to issue Activity Badges with validity periods up to 12 months
- Per Michelle Sowden, Protective Services Office:
 - due to changing Agency policy, future submissions for local badges (ie. Construction, LEA, carpool, vendor, alumni, etc...) can now be requested for **up to** 1 year at a time **as required**
- New Business discussion will provide proposed LAA implementation. This should provide workload reduction both for LaRC and LAA staff and fewer member trips to BPO.
- This does not affect the policies around the need for the member to be in good standing or to be actively participating in LAA monthly meetings. The need for physical access is still a NASA requirement.

IT Committee Report

- Received notice that our free Microsoft Business Premium plan will end on January 28, 2026 (renewal date)
- Will be replaced with Business Basic (up to 300 licenses)
- Still supports Teams and email addresses
- Details unclear, but expected to have little to no impact
 - Unable to get further information from Microsoft

Old Business – Outstanding Actions

- **Bring to the Board a proposal for the budget**, as discussed at the January 2024 Board meeting (Ray Rhew – March 2024 action)
 - Status: Ray provided overviews of the last 3 years and a notional proposed budget (see Treasurer's Report); Had Budget Development Process meeting with volunteers on April 17th.
 - May: Ray to bring an update in August.
 - August Update: Per Ray, in good shape to make some decisions on the discretionary Budget. Next step is to develop the plan to execute.
 - Oct/Nov Update: Per Ray, overall budget is good; want to refine discretionary budget. Keep action. Will discuss with Lil Richwine.
 - April Update: Ray provided budget overviews; Ray will provide update on outreach discretionary budget at a future meeting.
- **Retirement Protocol Question (Rich Antcliff)** – What is the protocol policy that NASA follows for retirements (album, certificates, party)? Should the LAA have one?
 - Nov Update: Contacted NASA Langley for information
 - April Update: Reaching out to Langley Human Capital

New Business - Membership

- NASA LaRC has a new option to issue Activity Badges with validity periods up to 12 months.
- **Motion: All new badges, along with issuing badges for members returning to activity after a lapse, are issued for 6 months. As badges are renewed, transition to 12 month duration as long as the member is currently in good standing and has fulfilled the frequency requirement.**
- Notes:
 - a) Some new members never become active.
 - b) Applies to existing members that are returning to activity after a lapse. This is to allow us to assess participation, hence the need, prior to extending to 12 months.
 - c) Retain the current good standing and frequency requirement
 - 1) It is working (badges are being denied due to inactivity or expired dues, no issues have come up at NASA)
 - 2) Analysis suggests that only 11% of badge holders are attending exactly the minimum, or 4% of the LAA membership. If half these are attending solely to keep a badge that is 2% of the LAA. Does not seem to be an issue.

New Business

- **Discussion: How do we help people see the value of LAA volunteering and want to help?**
 - My newsletter article; Reorganizing the Vice President responsibilities so more opportunities to volunteer
